Nascent was awarded the 2013 IFRP grant for Uganda in October 2013 to implement a 15 month program design to improve the nutritional health of 1390 food insecure families in the Kaberamaido and Serere districts of northern Uganda. The last consignment of donated program commodities sailed in 2015. The commodities were cleared and transported to the Uganda port of Entry in Mbale for final clearing by The Uganda Minister of Disaster Preparedness. The project staff in Uganda completed the sensitization of target communities and registration of beneficiaries in the target communities. The program successfully continued in 2015 and additional commodities are distributed.
